#### 174 Port Royal Flag Pole and Yardarm

Members were asked whether they wished to contribute half the cost of refurbishment of the weather vane, at a cost of £750, and if so where should be weathervane be relocated.

#### 175 Alma Bridge – Update from DCC

Nick Jennings, Principle Bridge Engineer, Devon County Council attended the meeting to give an update on Alma Bridge; he tabled plans of the proposed replacement bridge and reported that a two-month consultation process had now commenced. This would be followed by a design process with the intention of a replacement bridge being in place by April 2017. However, this would require some interim protection to Pennington Point; the cliffs were currently eroding at a rate of 2 metres per annum.

**RESOLVED:** that as part of consultation being carried out by Devon County Council on the revised location for a new Alma bridge, representatives of Natural England and the World Heritage site organisation would be invited to attend a future Town Council meeting at their earliest convenience to brief members on their thinking regarding the bridge and protection for the town from the sea.
