Dear Chris.

Thank you very much for making time to see me regarding further improvements to the football pitch at Manstone Lane.

As you are aware the Club would like to erect spectator railings to the north side of the football pitch and provide grasscrete hard standing also along that side.

The Club has now received confirmation from the EDDC Central Planning Team that the proposed post and rail fence to run parallel with the touchline does not require planning approval whilst the grasscrete hard standing has already been approved.

The east facing end of the pitch wlll continue to remain fully open providing unfettered public access to all parts of the park land.

I write therefore to request the Town Council, as our landlords, give their consent for the Club to proceed with these two linked improvements enabling our spectators to view matches from a safe and secure position.

Subject to the Council's consent we intend to commence the work at the end of this season.

I enclose a map setting out the proposed layout for your information and I look forward to hearing from you in due course.
