- “Once again, we would like to thank all the Town Council and the people of Sidmouth for welcoming us back for our second year, I do believe the fair went smoothly and was widely supported by the whole town. I know we had a little trouble on the Saturday night, but our security and staff handled it very well; to prevent this next year we could have double security. I understand it was raised in the Town Council meeting that we stayed open past our 9:30pm deadline but I can assure you this was not the case; all music was switched off at 9:30pm and the rides were not in operation. We did leave the lights on for an extra 20 minutes or so, but this was just to clear the site. We hope you feel that we left the site in the same condition that we pulled onto The Ham and we really hope we could come back next year.”

**5 Minutes**

**7 Salcombe Regis Recreation Field – Exeter Leukaemia Fund Fundraising Event**

A letter had been received requesting permission to use the Scout Centre, Salcombe Regis Recreation Field to run an invitation only fund-raising event for the Exeter Leukaemia Fund. The Chair asked Members to consider delegating authority for requests to use Salcombe Regis Recreation Field to the Town Clerk in consultation with the two ward Members for Salcombe Regis.

**RESOLVED:** that:

1. Authority to give permission for the use of Salcombe Regis Recreation Field be delegated to the Town Clerk in consultation with the two ward Members for Salcombe Regis.
2. Permission to use the Scout Centre, Salcombe Regis Recreation Field to run an invitation only fund-raising event for the Exeter Leukaemia Fund, on Saturday 7 September 2019, be granted.

**8 Salcombe Regis Recreation Field – Scout Group Raised Beds**

A letter had been received from the Scout Group requesting retrospective permission to install raised beds at Salcombe Regis Recreation Field.

**RESOLVED:** that:

1. Members reiterated that any such requests for building/ground works must be made in advance and not retrospectively.
2. Permission to install raised vegetable beds in their current position be refused.
