### 10 COVID 19: Social Distancing TTRO – Extension

The current COVID-19 Temporary Traffic Order in the town, to aid social distancing, runs until 31 December 2020. The Council may wish to consider a further extension to the order, with associated signage and resources, until the end of March 2021; considering that the COVID pandemic is still very much with us and the Government is encouraging the continuation of such schemes.

A further extension could be made while Devon County Council Highways and the Town Council continue to work together on possible formal future schemes for the town.

Councillors will recall they initially made up to £10,000 available for the first two Traffic Orders and associated signage and staffing resources required (Devon County Council paid half of the first scheme). Members are asked to consider a further extension which because of the earlier DCC contribution and lower costs of extension schemes would only need an additional £1,500 to be made available from General Reserves.

### 11 Manstone Skatepark – Lighting Scheme

Members will be aware that the new Manstone Skatepark, being constructed by Maverick Industries Ltd, is nearing completion and that it has been the intention to fit this with suitable timed lighting to enable its use throughout the winter months. A quote from Maverick's partner company Highlights Ltd, who would gain planning permission and construct the lighting on behalf of the Council, has been received together with the connection charge from Western Power Distribution.

The total costs of obtaining planning permission, plans, supply, build and new power connection is £29,125. It was hoped that a Sport England grant would be available, but this is still closed at present to local authorities with only a new fund for Sports Clubs directly affected by COVID being allowed to apply; other grants are being investigated by Maverick. It is suggested that as this is a significant infrastructure investment and to ensure the maximum usage of the new facility, Members consider taking this finance from the Community Infrastructure Levy (CIL) reserve which is currently £78,833. If other grants become available, the balance taken from CIL would be reduced accordingly.

Members are unable to support this application even with the removal of the car port for the reasons given below and wish to draw attention to the statements below taken from Pages 33 & 34 of the Sid Valley Place Analysis.

- Character; Views to the South over the town mainly suburban streets and culs de sac distinctive buildings acting as landmarks
- Connectivity; Mainly connecting streets and culs de sacs Links east towards the Byes Walking connections to Core Hill
- Street Pattern: Green connecting streets older rural green lanes embedded into the street layout. Green interfaces to Woolbrook Road, Bulverton Road and Sidford Road
- Landscape; Partly in the AONB and on the AONB Boundary long views of valley side to West Views of Core Hill to the North.

Also, detailed in the Sid Valley Neighbourhood Plan:

Policy 6 Infill development and Trees. Development should be designed so as not to adversely impact on the amenities of its neighbours and should seek to protect any existing trees that contribute to the overall amenity of the area, as well as being appropriately landscaped. A number of the trees are subject to TPO'S.

- Policy 9 Residential Development. The proposed development at the Reservoir must be compatible with the characteristics of the character area as described in the Place Analysis which the members do not think.
- Additionally, there were 2 garages that have been changed to storage and a gym back in February 2020, the Council were led to believe the car parking was not needed.
- Members also feel that there is plenty of parking in the area so the additional parking could not be justified.
- Members would like to see manageable and sustainable replanting in the area.

Note: Woolbrook Reservoir was an important area, included in the Local Plan as Land of Local Amenity Importance. Members would like to see a comprehensive plan for the area rather than respond to piecemeal applications.
