T2 To remove 1 Laylandii to ground level on Western boundary. Reason for works, Proximity to two dwellings, to allow Prunus Lusitanica to reestablish in border. T3 To reduce Prunus Lusitanica by approximately 25%. Reason for works, to achieve a robust structure to help prevent further limb failure and promote regrowth at a lower level.
