90 Minutes

The minutes of the meeting of the Town Council held on Monday 6 November 2023 were signed as a true and accurate record.

92 Matters of Urgency or Report from the Chair

- The Chair reminded Members of a forthcoming Briefing and Training session on Wednesday 10 January.
- The Chair reminded Members of the forthcoming Council meeting to agree the Budget and Estimates for 2024/25 and to be held on Monday 22 January.
- It was noted that Environment Committee Thermal Imaging surveys were again being carried out to help residents consider the efficiency of their home insulation. 125 homes had been surveyed in the past two winters so far. It was agreed that this should be extended to small businesses in future.
- It was noted that East Devon District Council has liaised with the Town Council regarding mowing regimes and that two distinct models were in the process of being adopted. One for a regular 2 weekly cut in and around housing and urban areas and the other for those areas considered to be allowed to grow 'wilder'. The Town Council had requested that the public be made more aware of the new cutting timetables via a joint press release.
- The Chair provided clarification regarding ownership and management of Trustee land on which a Member of the public had asked a question.
