### 6 Salcombe Regis Recreation Field – Biodiversity Plan

The 1<sup>st</sup> Sid Vale Scout Group has written to request permission to carry out work at Salcombe Regis Recreation Field, details as follows:

"At our last Scout Group Executive Meeting there was a discussion around the possibility to improve the biodiversity of the Salcombe Regis field not only so the Scout Group can work biodiversity and sustainability activity into the young people's programme, but also to improve the ecology of the area for the local community.

We therefore would like to seek approval from the Town Council for the following:

- 1. Create a 2m 'long-grass/wild-flower' strip on the southern edge of the field by the boundary.
- 2. Convert the existing camp-fire pit into a wet-land wildlife pond.
- 3. Create a new group (but smaller) fire-pit nearer the pavilion.

I have included a sketch of the proposed changes to help visualise our proposals. If there is general approval, our plan would be to work with a local conservationist/ecologist to ensure we do all we can to maximise biodiversity of the plans."

Members were asked to note that, using his delegated authority, the Town Clerk had, in consultation with the Chair and Ward Members, given permission to the Salcombe Regis Country Fair Committee to use the Salcombe Regis recreation field on Thursday 1 June 2023 for car parking for visitors to this year's Country Fair event.

### 25 Use of The Ham – Exe-Fest – Friday 9 to Sunday 11 June 2023

Oliver Bainbridge, Crossed Anchors Brewing, Exmouth, an event organiser in Exmouth had requested to use The Ham for an event he would like to bring to Sidmouth. "Exe-Fest a family orientated, free event in conjunction with the RNLI, which had been held in Exmouth for the last 5 years. We are known for running well organised events that are safe, community focused and very popular with local people."

### Description of Event:

A family and community-based event, with live music, stalls and food stalls. All focused on Devon produce, mission was to create safe spaces for the community to get together in pleasant surroundings and relax.

### 26 Use of The Ham – Folk Festival – Thursday 3 to Friday 11 August 2023

Jason Knight, General Manager, Sidmouth Folk Week Productions, had requested permission to use The Ham for this year's Folk Festival.

### Description of Event:

Sidmouth Folk Festival – multifaceted 9-day folk arts festival and associated trading.

- Set up Wednesday 26 July to Wednesday 2 August 8am to 6pm daily. (possibly quiet work post 6pm on Monday 31, Tuesday 1 and Wednesday 2)
- Take down –Friday 11 August after show quiet de-rig 11pm to 2amSaturday 12 to Tuesday 15 August 8am to 6pm daily

Event days – Thursday 3 to Friday 11 August 9am to 11pm daily

**RESOLVED:** That permission be granted to Sidmouth Folk Week Productions to use The Ham from Wednesday 26 July to Tuesday 15 August 2023, for this year's Folk Festival as applied for, subject to the following conditions:

- Set up Monday 31 July, Tuesday 1 and Wednesday 2 August if necessary, quiet work may be carried out between the hours of 6pm and 11pm. (Quiet Work is defined as "Indoor work or construction activity conducted on the construction site, which is NOT audible by adjacent sites by homeowners or visitors".)
- Take down Friday 11 August there is to be NO de-rig work of any kind to be carried out after 11pm following the Friday evening show.
